educate the public and federal, state and local government policy makers about the benefits of managed care; and



advocate for policies, legislation, regulations and government programs that promote health and improvements through managed care.

The education and advocacy efforts of CareSource Mission are vital tools to ensure that the public and elected officials support legislation and regulations that align with CareSource's mission to make a lasting difference in its members' lives by improving their health and well-being.
